EXPLANATION OF THE MEMBERSHIP FORM

- The Contact Section is for use by the Society only and will not be supplied to 3rd parties
- Email Address must be written clearly. Please notify the board should you change your details as this is our main means of contact.
- Your email address will be used to send bulletins and other specific and important information to you
- Membership Listing Details Please check you inclusion details on the membership list that is made available to members only
- Authorisation Forms are required if other parties will sign registration and transfer papers on your behalf (please download from the website)
- Stud/Stable name can be registered with the KFPS, if you want to have the sole right to use that name in conjunction with the name of foals that you may register. If you want to register this name, please tick the appropriate box on the form. A registration fee is payable and an annual subscription fee is charged. Note that a stable name is added to the end of the name. You may need to include a 'connector' such as 'of' 'van' or 'Fan' (Example Jonas of Black Horse Park in which 'Black Horse Park' is your stable name and 'of' is the connector)
- The attached 'Waiver' form is required by the AFHS insurance company.

AFHS MEMBERSHIP - this membership is mainly for members who want to be kept informed about the Society and don't breed or transfer horses.

- AFHS members cannot register/transfer horses or present horses at Keurings. It includes 4 editions of 'The Friesian' magazine
- AFHS members can enter horses in competitions/shows that require valid membership with a Society and have access to AFHS
 information on the AFHS website (members area included)
- AFHS members can participate in AFHS sponsored events and be covered by the AFHS liability insurance
- AFHS members have one vote when proposals and motions are presented

KFPS MEMBERSHIP - (fee includes AFHS membership as above) This membership is aimed at members that are actively breeding Friesian horses and is required for transferring horses and being reissued with KFPS registration papers.

- Includes the privileges the AFHS membership (as above)
- KFPS membership enables access to 'MYKFPS' on the KFPS.nl website for information and notification of foals born.
- KFPS members can register/transfer horses within the KFPS/AFHS
- KFPS members can present horses at Keuring days (judged by the KFPS) and enjoy discounts at specific events in the Netherlands

AFHS ASSOCIATE FEE

This fee is to cover any person/parties that will participate in AFHS sanctioned events that need third party liability cover. This may include riding and/or driving a horse during an event. This membership does not include the magazine and other bulletins. This cover is purely to cover members for Public Liability when participating with a horse.

IMPORTANT to ensure your Phryso magazine gets delivered to you on time, your membership needs to be before the end of January as the KFPS start mailing them out. Members have been overlooked for some months should they pay late.

Interested in knowing what your fees pay for?

\$70 goes directly to the KFPS in the Netherlands.

\$80 goes towards the quarterly edition of the magazine and Liability Insurance

The remaining fee is used as general income to operate AFHS administration.

HORSE SPORTS ARE A DANGEROUS ACTIVITY

In consideration for being permitted to participate in any way in horse sport activities, I the undersigned understand, acknowledge and accept that horse sports are a dangerous recreational activity and horse can act in sudden and unpredictable (changeable) way, especially if frightened or hurt. There is a significant risk that serious INJURY or DEATH may result from horse sport activities.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Australian Friesian Horse Society Incorporated and I voluntarily participate at MY OWN RISK and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities or any other AFHS activity.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during any AFHS Inc. organised activity and I take full responsibility for any

injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during any horse sport activity.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of organisers or officials can result in CANCELLATION of my participation in any



event and the immediate removal from my horse NO MATTER where that may occur. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the AFHS Inc. against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all time during ridden horse sport activities and I agree that I am solely responsible for ensuring that I wear a helmet at all times and take sole responsibility of my horse and my actions.

I agree not to sue the AFHS Inc. (including their officers, officials, volunteers, coaches, agents and/or employees/board members, other participants, sponsors and if applicable owners and lessors of premiseS used to conduct the events) with respect to ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE AFHS Inc. OR OTHERWISE.

EFFECT OF THIS DOCUMENT

I have had sufficient opportunity to read this release of liability and assumption or risk agreement, fully understand
its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without
inducement of any kind. I understand that my signature to this document constitutes a complete and unconditional
release of all liability to the AFHS Inc. to the greatest extent allowed by law in the event of me and/or the children
under my care, suffering injury or death.
